Professor Floya Anthias

Floya Anthias is Professor of Sociology at Oxford Brookes University in the United Kingdom. Her political and research concerns span the different dimensions of inequality and disempowerment. She has published extensively on social divisions, racism, ethnicity, migration and gender as well as Cypriots in Britain. Her work has included an analysis of social divisions and in particular the links between gender, ethnicity and class, rethinking the link between "ethnic" and "race" categories, critiquing the use of "culture" and "community" in multiculturalist discourse and practice, stressing the centrality for gender for social relations with a particular interest in the links between gender and ethnic, "race" and national processes, and contributing to recent debates on feminism and multiculturalism and on transnationalism, diaspora and hybridity.

Dr. Alperhan Babacan

Alperhan Babacan is currently a post- doctoral research fellow at the Centre for Applied Social Research, RMIT University, Australia. Alperhan holds a Bachelor of Arts (Hons.) (Political Science and Middle Eastern Studies) from the University of Melbourne, a Bachelor of Law (Hons) from La Trobe University and a PhD from RMIT University. He has worked extensively with immigrants and refugees both at the community level and in local and Commonwealth Governments. Alperhan also practiced law for a period of nearly ten years. He actively researches in the areas of globalisation, citizenship theory, refugee and asylum law and policy, human rights and multiculturalism.

Associate Professor Danny Ben-Moshe

Danny Ben-Moshe directs the Institute for Community Engagement and Policy Alternatives at the Victoria University, Melbourne, Australia. He has published widely in racism and anti-Semitism, the subject of his PhD from Melbourne University. He was previously the Director of the B'nai B'rith Ant-Defamation Commission. He was awarded a Centenary of Federation medal for leadership against and research into racism in Australia. He is currently producing a documentary film for SBS Television, Australia, about a group of Holocaust survivors in Australia.

Dr. Santina Bertone

Dr. Santina Bertone is currently Head of the Work and Economic Policy Research Unit and Associate Dean (Research) at Victoria University. She has undertaken a large range of research projects over the past 15 years into multiculturalism, diversity in the workplace and workplace change. Santina has produced 8 books and numerous book chapters, papers and journal articles in these areas. More recently, Santina has moved into policy and practice in the community building area and has extended her research interests to the link between social capital, diversity and economic development.

Professor Linda Briskman

Linda Briskman is Professor of Human Rights at Curtin University, Australia. She has published extensively on the issues of Indigenous people and asylum seekers in Australia. She is currently convening a people's enquiry into immigration detention, auspiced by the Australian Council of Heads of Schools of Social Work. Linda has many years of research and practice among Indigenous communities, especially around the issues of homelessness and child welfare. She continues to work internationally on many of these issues as part of an international consortium or research publications.

Professor Jock Collins

Jock Collins is Professor of Economics, School of Finance and Economics, Faculty of Business, University of Technology, Sydney, Australia. He has been researching and writing about Australian immigration and cultural diversity for thirty years. His books include Migrant Hands in a Distant Land: Australia's Post-War Immigration (Pluto Press 1998 and 1991) A Shop Full of Dreams: Ethnic Small Business in Australia (with others (Pluto Press 1995) Kebabs, Kids, Cops and Crime (with others (Pluto Press 2000) and Cosmopolitan Sydney: Exploring the World in One City (with Antonio Castillo Pluto Press 1998). His latest book, Bin Laden in the Suburbs: the Criminalisation of the Arabic Other (with Scott Poynting, Greg Nobel and Paul Tabar) was published by Federation Press, Sydney, in 2004. His work has been translated into French, Japanese, Italian, and Arabic.

Dr. Kevin Dunn

Kevin Dunn is a Senior Lecturer in Geography, at the University of New South Wales, Australia, where he teaches cultural and social geography. Kevin's major research interest is the cultural geography of citizenship in Australia. It ans involved five core research streams: geographies of racism; immigration and transnationalism; Australian Islam; Multiculturalism, national and local identities and citizenship; theorising memorialisation and cultural landscapes. Along with colleagues at UNSW and Macquarie University, Kevin has lead the Geographies of Racism project since 1998. In 2004, he developed the Geographies of Racism website, where data sets on racist attitudes and experiences have been posted, a strong resource for all levels of government as also local communities. His recent books include *Landscapes: Ways of Imagining the World*, and articles in *Society and Space*, *The Australian Geographer, Media International Australia*, and the *Australian Journal of Social Issues*. He is a fellow of the New South Wales Geographical Society and past Secretary.

Ms Nahanni Fontaine

Nahanni Fontaine is the Director for Justice for the Southern Chiefs' Organisation (SCO), a political Indigenous organisation representing 36 Southern First Nations in Manitoba, Canada. As the Director of Justice, Ms. Fontaine supports the mandate and vision of SCO and its member constituencies by providing technical analysis, advocacy and support. SCO's Department of Justice currently addresses the areas of policing; public complaints; devolution of probations and community corrections services; gang research and prevention; restorative justice; judicial policy and development; and the move towards a parallel Indigenous justice system. Ms Fontaine is an Ojibway First Nations woman from the Sagkeeng Anishinaabe First Nation in Southern Manitoba. She has served the Aboriginal community regionally, provincially, nationally, and internationally on a myriad of boards, committees, workshops and presentations in the areas of social justice, human rights, indigenous women's and children's rights and Treaty implementation over the last ten years.

Associate Professor Jim Forrest

Jim Forrest is an Associate Professor at the Department of Human Geography at Macquarie University, Australia where he teaches in social, political (electoral) and urban geography. His research interests are mainly in the social and electoral areas, focusing on geographies of advantage and disadvantage, most recently on ethnic group disadvantage. This area of work is currently being extended into research into geographies of racism. Work on electoral geography especially looks at relationships between money and voting outcomes, at geographies of inter-election change, and at state effects in Australian political behaviour. As a member of the Higher School Certificate syllabus committee he has written a number of papers and texts on urban geography, and is currently involved in a re-write for the new Higher School Certificate syllabus. He is currently President of the New South Wales Geographical Society

Ms Jackie Huggins

Jackie Huggins is an Australian icon. Her heritage, her intellect, experiences and love of history have all contributed to her deep understanding of life and people and have made her a force behind important Indigenous initiatives in Queensland and Australia. Jackie is of the Bidjara (Central Queensland) and Birri-Gubba Juru (north Queensland) peoples. She has been an influential member of many organisations and is currently co-chair of Reconciliation Australia, in addition to many other appointments relating to Indigenous affairs. In 2001, Jackie Huggins was awarded an Order of Australia for her services to the Indigenous community, particularly her work with reconciliation, literacy, women's issues and social justice.

Dr. Rahil Ismail

Rahil Ismail is an Assistant Professor at the National Institute of Education, Singapore. She earned her PhD in International Studies from the University of Leeds, UK. Her research areas include Multicultural Studies, Heritage Studies and Conflict in the New World Order.

Dr. Chris Sonn

Dr Chris Sonn is a senior lecturer at Victoria University, Australia. Chris teaches in both the undergraduate and postgraduate programs at Victoria University in areas of community and cultural psychology and qualitative research methods. Chris' research is in the area of sense of community and intergroup relations and community cultural development. A major focus of his research is on understanding non-dominant group responses to oppression and exclusion, including racism. He has investigated the adaptation of different immigrant communities to Australia as well as the responses of Indigenous Australians to dominant group setting and stories. His focus is on understanding the multiple and often hidden resources and structures groups develop to help protect valued cultural identities and to resist oppression. While he lived in Perth, he worked with the Community Arts Network exploring ways in which community arts and cultural planning can be utilised in community capacity building.

Mr. Basil Varghese

Basil Varghese has been dedicated over the last three decades to working with and for the disadvantaged in Australian society. Since 1988, Basil has worked with the Brotherhood of St. Laurence, Australia, as their Education Coordinator and Ambassador, sharing the Brotherhood's work and vision for an Australia free of poverty with business groups, churches, unions, schools and tertiary institutions. Basil's strong and ongoing commitment to social justice and his engagement with the community have made him a leading figure in challenging attitudes to poverty in Australia.
