**Simon Marginson** is Professor of Higher Education at the University of Melbourne, Australia, where he works in that University's Centre for the Study of Higher Education. He was elected as Fellow of the Academy of Social Sciences, Australia in 2000, designated an Australian Research Council Australian Professorial Fellow in 2002, and has held continuous Australian Research Council project funding since 1995. During an academic career dating from 1993 he has developed work on, successively, higher education and education policy, comparative and international education, studies of globalization, and the knowledge economy and creativity. He is a member of the boards of the *Journal of South East Asian Education*, the *Journal of Education and Work*, *Higher Education*, *Higher Education Quarterly*, *Thesis Eleven*, the *ASHE Reader on Comparative Education*, *Critical Studies in Education*, *Higher Education Policy*, *Asia-Pacific Journal of Education* and the *Journal of Higher Education* and edited the *Australian Journal of Education* from 1995–2000. His academic awards include the Outstanding Publications Award of the American Educational Research Association Division J, for 2001 (with Mark Considine) and the George Z. F. Bereday award for the best journal article of 2001, Comparative and International Education Society, in 2002 (with Marcela Mollis, University of Buenos Aires). He has published eight sole authored or jointly authored books, 51 chapters, 73 refereed journal articles, 20 review essays and reviews, and numerous other journal articles as well as media commentary, policy monographs, government reports and contributions to policy debate. His books include *Markets in Education* (1997), *The Enterprise University: Power, Governance and Reinvention in Australia* (2000), *Prospects of Higher Education: Globalization, Market Competition, Public Goods and the Future of the*

*University* (2007), *Creativity in the Global Knowledge Economy* (with Michael Peters and Peter Murphy, 2009) and *International Student Security* (with Chris Nyland, Erlenawati Sawir and Helen Forbes-Mewett, forthcoming). He is active in scholarly circles throughout the world, particularly in the Asia-Pacific, Europe, and North America and Mexico; has provided advice on higher education and globalization for the governments of Australia, Malaysia, Hong Kong, Vietnam and New Zealand, is frequently called on to provide papers in relation to university comparison and ranking, and has completed several policy papers for the OECD including two chapters on *Higher Education and Globalization* (with Marijk van der Wende, forthcoming), and the 2007–2008 thematic review of tertiary education in the Netherlands. Four of his books have been published in China and a fifth book on higher education and globalization is presently being translated for publication by Peking University Press.

**Peter Murphy** is associate professor of communications at Monash University, Australia. He is co-author of *Creativity and the Global Knowledge Economy* (Peter Lang, 2009) and *Dialectic of Romanticism: A Critique of Modernism* (Continuum, 2004), author of *Civic Justice: From Greek Antiquity to the Modern World* (Prometheus/Humanity Books, 2001), co-editor of *Agon, Logos, Polis* (Franz Steiner, 2000) and *The Left in Search of a Center* (University of Illinois Press, 1996), and editor of a special issue of *South Atlantic Quarterly* on friendship (Duke University Press, 1998). His body of work includes more than seventy journal articles and chapters in edited collections. He has been research fellow and visiting professor of philosophy in the Graduate Faculty of the New School for Social Research in New York City; visiting scholar in the Hellenic language and literatures programme at the Ohio State University; visiting scholar at Panteion University in Athens, Greece; visiting professor in political science at Baylor University, Texas; director of the master of communications programme at Victoria University of Wellington, New Zealand; visiting research fellow in philosophy at Ateneo de Manila University in the Philippines; and visiting professor in communications and media studies at Seoul National University, South Korea, and in the Department of Arts and Cultural Studies at the University of Copenhagen, Denmark. He is coordinating editor of the international critical theory and historical sociology journal *Thesis Eleven: Critical Theory and Historical Sociology* (Sage), and from 1998 to 2001 worked in senior editorial roles for Australia's most successful Internet start-up company, Looksmart.

**Michael A. Peters** is Professor of Education in the Department of Educational Policy Studies at the University of Illinois at Urbana-Champaign and holds a position as Adjunct Professor at the Royal Melbourne Institute of Technology (School of Art). He held joint professorial positions at the Universities of Auckland (NZ) and Glasgow (UK). He was elected Academic Vice-President of the New Zealand Association of University Teachers and elected an inaugural Fellow of the New Zealand Academy of Humanities. He is the executive editor of *Educational*



*Philosophy and Theory* (Wiley-Blackwell) and editor of two international journals, *Policy Futures in Education* and *E-Learning* (Symposium). His interests focus broadly on education, philosophy, and social theory and he has written some forty books and many academic papers, including most recently: *Creativity and the Global Knowledge Economy* (Peter Lang, 2009) with Simon Marginson and Peter Murphy; *Showing and Doing: Wittgenstein as a Pedagogical Philosopher* (Paradigm, 2008) with Nick Burbules and Paul Smeyers; *Global Knowledge Cultures* (Sense) with Cushla Kapitzke; *Subjectivity and Truth: Foucault, Education, and The Culture of Self* (Peter Lang, 2008) with Tina Besley; *Why Foucault? New Directions in Educational Research* (Peter Lang, 2007) with Tina Besley; *Knowledge Economy, Development and the Future of the University* (Sense, 2007); and *Building Knowledge Cultures: Educational and Development in the Age of Knowledge Capitalism* (Rowman & Littlefield, 2006), with Tina Besley.
