Andy Bennett is Professor of Cultural Sociology and Deputy Director of the Centre for Public Culture and Ideas at Griffith University, Australia. He is author of *Popular Music and Youth Culture: Music, Identity and Place* (2000), *Cultures of Popular Music* (2001), *Culture and Everyday Life* (2005) and *Growing Old Disgracefully? Popular Music Fandom and Ageing* (forthcoming). He is a Faculty Associate of the Center for Cultural Sociology at Yale University, an Associate of PopuLU, the Centre for the Study of the World's Popular Musics at Leeds University, and a member of the Board for the European Sociological Association Network for the Sociology of the Arts.

Claudio E. Benzecry is an Assistant Professor in the Department of Sociology at the University of Connecticut. He is currently completing a manuscript under contract with University of Chicago Press, *The Opera Fanatic: Ethnography of an Obsession* and co-editing a special issue of *Qualitative Sociology* on Knowledge in Practice. He also has a new project, in collaboration with Andrew Deener, looking at the micro level of the political economy of fashion globalization, focusing on trend forecasting agencies and second-rate clothing and accessories companies and the ways in which they participate in producing both patterns of innovation and reproduction. Recent publications have appeared in *Theory and Society*, *Ethnography*, and *Theory, Culture and Society*.

Dan Black is Lecturer in Communication and Media Studies, School of English, Communications and Performance Studies, Monash University. He has written for journals such as *The Journal of Popular Culture*, *Fibreculture*, and *Continuum*, and is editor (with A. Tokita and S. Epstein) of *Complicated Currents: Media Production, the Korean Wave, and Soft Power in East Asia* (2010). His research interests focus on the relationship between the human body and technology.

Joseph Borlagdan is a Lecturer in the National Centre for Education on Training and Addiction at Flinders University. He is currently working on a project exploring the cultural influences on alcohol use amongst young Australians. He has taught in the Sociology Department of Flinders University and the Communication School of the University of South Australia. His PhD research, completed in 2005, examined the cultural and social context in which young people actively produce their own underground music community.

Eduardo De La Fuente is Lecturer in Communications and Deputy Director of the Social Aesthetics Research Unit at Monash University, Australia. He is also co-convenor of the Australian Cultural Sociology Group and a permanent Faculty Fellow of the Center for Cultural Sociology, Yale University. He is author *Twentieth Century Music and the Question of Modernity* (Routledge, 2010), and has published articles in the *Journal of Sociology*, *Thesis Eleven*, *Distinktion*, *Cultural Sociology* and *Sociological Theory*. He is an editor of the journal *Thesis Eleven* and is on the Editorial Advisory Board of the *Journal of Sociology* and *Apuntes* (the journal of the Sociological Association of Argentina).

Stuart Grant is Lecturer in Drama and Theatre and in Communications at Monash University. His writings have appeared in *Phaenex*, the *Warwick Journal of Philosophy*, *Janus Head*, *About Performance*, and *Unstable Ground: Performance and the Politics of Place*.

Agnes Heller is Emeritus Professor of Philosophy at the New School for Social Research. She is the author of over 40 books, including *Immortal Comedy: The Comic Phenomenon in Art, Literature, and Life* (2005), *The Time is Out of Joint: Shakespeare as Philosopher of History* (2002), *A Theory of Modernity* (1999), *The Concept of the Beautiful* (1999), *An Ethics of Personality* (1996) and *A Philosophy of History in Fragments* (1993). Awards for Agnes Heller's intellectual achievements include the 2006 Sonning Prize, Denmark; the Hannah Arendt Prize for Political Philosophy, Bremen, 1995; the Szechenyi National Prize, Hungary, 1995; the Lessing Prize of the Free and Hanseatic City of Hamburg for Philosophical Activity, 1981. She is a Correspondent-Member of the Hungarian Academy of Sciences.

Mark Jennings is a doctoral research student at Murdoch University in Western Australia. His thesis explores the ways people make use of contemporary music, and uses ethnographic methods to compare the significance

and function of music and religion in a Pentecostal church setting and in a Blues music festival.

Peter Murphy is Associate Professor in Communications and Director of the Social Aesthetics Research Unit at Monash University. His books include *Global Creation* (Peter Lang, 2009), *Creativity and the Global Knowledge Economy* (Peter Lang, 2009), *Dialectic of Romanticism: A Critique of Modernism* (Continuum, 2004) and *Civic Justice: From Greek Antiquity to the Modern World* (Prometheus/Humanity Books, 2001). He is co-editor of *The Left in Search of a Center* (University of Illinois Press, 1996) and *Agon, Logos, Polis* (Franz Steiner Verlag, 2001) and Coordinating Editor of the international journal *Thesis Eleven: Critical Theory and Historical Sociology* (Sage).

David Roberts is Emeritus Professor of German, Monash University. His many publications include *Art and Enlightenment: Aesthetic Theory after Adorno* (1990), *Reconstructing Theory: Gadamer, Habermas, Luhmann* (1995), *Canetti's Counter-Image of Society: Crowds, Power, Transformation* (2004), *Dialectic of Romanticism: A Critique of Modernism* (2004), and forthcoming *The Total Work of Art in European Modernism*. He is a member of the editorial board of *Thesis Eleven*.

John Rundell is Reader in Social Theory and Director of The Ashworth Program in Social Theory, School of Social and Environmental Enquiry, University of Melbourne. He is author of *Origins of Modernity: The Origins of Modern Social Theory from Kant to Hegel to Marx* and has jointly edited *Between Totalitarianism and Postmodernity* (with Peter Beilharz and Gillian Robinson), *Rethinking Imagination: Culture and Creativity* (with Gillian Robinson), *Culture and Civilization: Classical and Critical Readings* (with Stephen Menell), *Blurred Boundaries: Migration, Ethnicity, Citizenship* (with Rainer Bauboeck), *Critical Theory After Habermas Encounters and Departures* (with Dieter Freundlieb and Wayne Hudson), and *Contemporary Perspectives in Social and Critical Philosophy* (with Danielle Petherbridge et al.).

Graeme Smith is Lecturer in Musicology and Convenor of Ethnomusicology, School of Music-Conservatorium, Monash University. Much of his recent research has been directed to the recent book *Singing Australian: A History of Folk and Country Music* (Pluto Press, 2005). In this book he traces the history of these musical scenes showing how they have entered into the many-sided

debates on community, nation and identity which have dominated public discourse over the last thirty years.

Alison Tokita is Director of the Japanese Studies Centre, Monash University. She has written widely on Japanese performing arts, especially music and sung story-telling (*katarimono*). Tokita is the author of *Kiyomoto-bushi: Narrative Music of the Kabuki Theatre* (1999), and is the editor of *Japanese Music: History, Performance, Research with D. Hughes* (2003), *Nihon no katarimono: koto-sei, kozo, igi* (*Japanese musical narratives: orality, structures, meanings*) (2002), and *Complicated Currents: Media Production, the Korean Wave, and Soft Power in East Asia* with D. Black and S. Epstein (2010).
